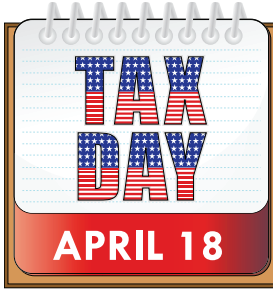

You can contribute to your 2016 IRA until April 18, 2017

April 15, the normal tax filing deadline, is on Saturday this year. That bumps the deadline for Massachusetts residents to Tuesday, April 18 because Patriots Day (April 17) is a state holiday.

That also means you have until April 18 to contribute to an IRA and get the tax benefit for 2016. Every dollar you contribute to a qualifying IRA (to the extent allowed by law), reduces your taxable income, and therefore your tax liability. It's almost like free money!

We don't recommend waiting until the last minute, so you may want to plan ahead to take advantage of these specials. That way you can enjoy the long weekend without worrying about coming in on Tuesday.

We will have a special gift for everyone who opens a new IRA or contributes to an existing one. Don't miss out on this chance to save for your retirement!

2016: The Year in Review

The financial results for 2106 continued in a positive direction. We sustained moderate growth by increasing our total assets from \$15,302,302 to \$15,726,566 or 2.8% since December of 2015.

Our loan portfolio also grew by \$536,690 or 5.2%. Our share balances grew from \$13,378,339 to 13,755,935, an increase of 2.8%.

Our membership increased from 1,807 members in December of 2015 to 1,838 members at the end of 2016, an increase of 1.72%.

Our income for the year was \$42,267, more than double our earnings in 2015. Our return on average assets as of year-end was 0.27%, a significant improvement over 2015, with a ratio of 0.13%. RAH remains well capitalized with a net worth ratio of 11.99%. The NCUA classifies a credit union as "well capitalized" if the ratio is 6% or greater.

Our delinquency ratio is 0.30% of loans outstanding, far below the experience of our peer credit unions. We increased our allowance for loan losses from \$30,038 to \$33,165 as of De-

cember 31, 2016. We will continue to increase the allowance to be well prepared in the event of future loan losses.

We invested in our facilities by seal-coating and re-striping our parking lot and also by performing some roofing and insulation repair.

The staff and I look forward to continuing our growth and profitability in 2017 and also to providing expanded and enhanced products and services to meet the needs of our members.

Members were "Wearin' the Green" when they came in for Member Appreciation Day on St. Patrick's Day. Everyone was entered into a raffle to win a goody basket.



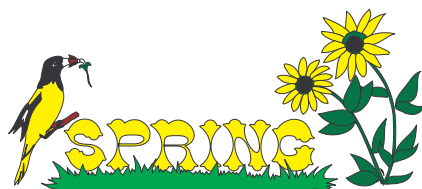

Cleaning Time

For your home

Although spring cleaning may seem overwhelming, the results—a neat and clean home—make it worthwhile. Here are a few tips to help you spruce things up, save money on cleaning products, and be kind to the environment.

Disinfect your Washing Machine

Run the machine with hot water, add vinegar and baking soda, and let it sit for 30 to 60 minutes. Afterwards, restart your machine, let the water drain, and wipe it dry.

Banish Dust Bunnies

Swish your broom around in warm, soapy water as needed then let it dry.

Let it Shine

Fill a spray bottle with a mixture of 50 percent rubbing alcohol and 50 percent water. Spray on your chrome, glass, or steel appliances, then wipe dry with a soft, non-linty cloth.
